Despite the Horsham Planning Inspector's firm rejection of **Mayfield Market Towns (MMT)**, this company, financed by Peter Freeman of Argent LLP, is **continuing its relentless assault on our countryside, our communities and our local councils.**

MMT and its slick team of professionals have taken every opportunity to object not only to the Mid Sussex and Horsham District Plans, but also to the Crawley, Lewes and Brighton and Hove Plans. Last month they made new objections to Horsham's modified plan (which exactly complies with the Inspector's recommendations) - they have even criticised the Inspector himself!

**It is clear that despite the obvious injustice of this ruthless and deeply undemocratic attack, we need to dig deeper into our pockets. The LAMBS committee is working flat-out, but what we need more than anything is to replenish our fighting fund!**

Last year thanks to the money raised by this community, LAMBS was able to provide vital evidence and professional legal support at the Examination of the Horsham Plan. The result was that Inspector **ruled out** MMT's new town proposal. That was a huge step in the right direction!
